

What do we do?

Inheritance Act claims

We help you understand, assess and progress your matter. Inheritance Act claims refer to an individual claiming under the Inheritance (Provision for Family and Dependants) Act 1975. In short, the Act allows for certain categories of people to bring a claim against the estate of a deceased person where 'reasonable financial provision' has not been made for them, or where they are an executor/administrator of an estate facing such a claim.

Whether you feel you have been left out of a Will and believe you are entitled to bring an Inheritance Act claim, or you find yourself in the position of defending such claims, we are on hand to guide and advise you through the entire process, with amicable or robust representation as necessary,

We ensure clients reach a satisfactory conclusion, in often difficult circumstances. We often promote the use of alternative dispute resolution such as mediation or negotating an out of court settlement via solicitors. When emotions are high and resources can be limited, a dispute involving the courts may not be the most welcome avenue.





Will disputes

We identify the strengths and weaknesses in your circumstances and help you to progress. Discovering that the provisions made in a Will aren't what you were expecting can come as a great shock, at an already shocking time. Whether it's the discovery that you have been left out of a Will or that a person or organisation has been unexpectedly included, a dispute over provisions in a Will of a lost loved one can cause great stress and anxiety, in addition to financial pressures.

Although any Will can be challenged in UK law, a Will can only be successfully challenged on one or more of five very specific grounds, which you will have to prove. There are often circumstances which people mistakenly believe are valid reasons to dispute a Will, but which, have little to no chance of being successful in law.

Our team will align with you to formulate a legitimate position to challenge the Will, if that is applicable. We advise you on the best course of action, given the options available to you, while explaining the likely advantages, costs and risks of pursuing your claim against the estate, or how else to approach settling it.
